Cardholder data is captured via NFC interface of POS terminals of external service provider with the Company's control board. This is the only cardholder data capture method. Then cardholder data captured by POS terminals is sent via Company's payment applications to different payment processors for transaction authorization. The Company processes over 10 million card present transactions annually.</p>

The Company captures CHD via NFC interface of POS terminals from its merchants. Encrypted CHD from POS terminals is sent via backend PaymentCard.CommunicationService to PaymentCard.ProcessingService application. Then PaymentCard.ProcessingService forms the message with encrypted CHD which is sent via PaymentCard.GatewayService to the payments processors for transaction authorization and extracts masked PAN and EXPDATE for storage. The PaymentCard.WebService saves masked PAN and EXPDATE to the Company's database for storing and performing forensics operations. All communications are performed via secure protocol HTTPS with TLS 1.2.
